

Conditions for Participation

At home in the great outdoors – on a canoe trip with Stetson Europe in 2022

The deadline for entries is **January 31, 2022**.

Stetson Europe will pay for two persons for an eight-day canoe trip in Sweden conducted by tour operator Outdoor Sweden, including flight tickets to and from Stockholm from one of the above listed airports and travel to the canoe camp. Also included is an overnight stay in a tent before the start of the canoe trip at the nature camping ground at the canoe camp lake, and one overnight hotel stay before your flight back with a standard double room including breakfast in a centrally located hotel in Stockholm. During the canoe trip, overnight accommodations will be provided in tents in the backcountry ([everyman's right](#)) or in simple rest areas. The travel dates are freely selectable in the period between May and September (status as of June 2, 2021), will be reviewed and finalized between FWS and the tour operator and must be specified for the year 2022. The tour includes canoeing instructions, consultation on site, a canoe with full equipment, water-tight luggage containers, outdoor equipment such as camping stoves, a saw or ax, maps, canoe transport to the starting point, a 24/7 emergency hotline, fishing equipment and fishing license. The winner will receive a checklist of items to pack before departure. Also included is a Stetson outdoor package comprising a Leatherman multi-tool, two Dowabo bottles, two trucker caps, two Stetson theme shirts and two Stetson gym bags. Good swimming skills are required.

The following services are not included and the costs must be borne by the winner and his/her companion: The fees for camping/rest areas that can be requested by the travelers (approx. EUR 2.00 per night) and provisions. In addition, the winner and his/her companion must also bring the following: camping sleeping pad and sleeping bag, waterproof clothing/foul-weather gear, other camping equipment and personal items.

The winner will be determined in a prize draw and will be notified by email. To assert his/her claim to the prize, the winner is requested to send a response within seven days of receiving the notification. If the winner cannot be reached via the contact details provided or if the winner does not respond to the notification within the specified period, he/she will be disqualified and an alternative winner will be drawn from the existing entries.

In the event that a participant is disqualified based on the terms of participation, an alternative winner will likewise be drawn from the existing entries. Only one entry is allowed per person. The participants must be of age and must have provided their correct names. FWS employees and customers may not participate in the prize draw. Photos and names of the winners may be published. The judges' decision is final. By participating, the participant agrees that Stetson Europe and all parties involved in these sweepstakes are not liable in the event of any complaints, damages, losses or injuries including third party claims that arise in connection with these sweepstakes, including the participation in the sweepstakes itself and misuse, acceptance and redemption of the prize. Payout of cash is not possible. These sweepstakes are governed by German law. The courts in Cologne, Germany, have jurisdiction in the event of any disputes in relation to these sweepstakes.
